

## **Call for Ideas**

### **Competitive Grant Facility for Work Force Development**

#### Introduction

In December 2011, MCC selected Georgia as eligible to develop a second MCC five-year compact to promote sustainable economic growth and poverty reduction. As part of the compact development process, the Government of Georgia (GoG) identified a need to improve the quality of human capital, particularly to address a shortage of skilled technicians and professionals in key economic sectors as a constraint to the country's continued growth. The GoG then proposed a compact program to address this constraint, including professional education or technical/vocational education and training (TVET).

A number of recent reports have highlighted the mismatch between the skills available in the Georgian labor market and the skills needed by industry. These reports emphasize the need to develop quality job skills in order to meet the needs of industry and business. This research indicates a priority to develop level IV and V job skills, especially in the broad areas of construction, transport, information technologies, and agriculture (including but not limited to primary production, processing, and value adding). While the activities proposed for the TVET project of the compact program will emphasize job skills at levels IV and V in the areas listed above, there also are needs to develop short-term training programs at levels I to III, as well as continuous education and re-training opportunities. Proposals in the technical areas not listed above will also be considered.

Recent studies also show that, although existing TVET programs – particularly at levels I to III – provide opportunities to socially vulnerable<sup>1</sup> students, they also exhibit sizeable gender imbalance in program enrollments and returns to training. In particular, a smaller share of women than men enroll in some types of professional skills/TVET programs. For levels IV and V, attention will need to be paid to ensuring the equitable participation of students from socially vulnerable and/or language minority groups.

#### Objective of the “Call for Ideas”

The Call for Ideas is intended to inform the design of the proposed TVET project in the compact. It is an opportunity to gather ideas on the types and scale of programs/practices that might be funded as part of the proposed compact. Using information from the Call for Ideas, MCA-Georgia<sup>2</sup> (MCA-G) and MCC will design a competitive grant facility as part of the proposed compact. Following approval and signature of the proposed compact, MCA-G will finalize the documentation for the competitive grant facility and commence the process of calling for proposals for programs/practices to be funded as part of the proposed compact.

#### Competitive Grant Facility

The Government of Georgia and MCC are contemplating that the proposed compact will include a competitive grant facility of approximately USD \$12-15 million to co-finance investments in industry-led skills and workforce development programs. The facility will consist of two components as described below. In order to achieve substantial impact and reach broad beneficiaries, a range of proposals, including those requiring considerable financial support and those requiring relatively less financial support, are acceptable.

Component 1 – Course-related Program Development Grants: Grants will be provided to existing organizations to either establish new course programs or to upgrade or expand their current programs; the focus will be on training in

the areas where providers can demonstrate a strong demand in the market.<sup>3</sup> Selected programs may receive technical assistance to support effective implementation. Possible types of investments include: facility improvement; equipment; teacher professional development; curricula development; twinning with a foreign provider; or other technical assistance. As part of proposals, or as a form of technical assistance, twinning relationships with foreign providers are encouraged. Curriculum, and practices developed under Course-related Program Development Grants would be required to be shared with other providers. As part of the Grants, recipients will be required to document and disseminate these curriculums, and practices along with lessons learned from use of the Grants. Course-related Program Development Grants may range between USD \$500,000 - \$3 million.

**Component 2 – Best Practice Grants:** **Best Practice Grants** will identify and support existing or promising provider procedures, operations, and other best practices not directly related to new course program development. Examples of best practices could include the use of industry discipline-based advisory boards, development or expansion of the use of competency-based training (CBT) curricula, the availability of career advice services or incentives that promote gender and social equity in program participation and job placement, the use of industry specialists as practical skills teachers, outreach and support activities that promote access for disadvantaged groups. Best Practice Grants would support TVET provider best practice and would fund the documentation and dissemination of the identified best practice. Best Practice Grants may range between USD \$100,000 - \$400,000.

#### Who should reply to the Call for Ideas?

The Call for Ideas is open to any government agency, public or private company or corporation, professional association, TVET college or university, NGO, or other legal entity active or planning to be active in Georgia in the provision of professional/technical training and education. The training programs should result in professional certificates, diplomas or otherwise measurable skills that allow trainees/graduates to respond to job-market demands – key criteria include number of employed beneficiaries and increased incomes of beneficiaries. Internal programs limited to corporate employees are not eligible.

Training providers (public and private), and businesses may suggest ideas for either:

- 1) creating new program offerings or upgrading or expanding existing programs; or
- 2) supporting, documenting, and sharing best practice in delivering professional education/TVET.

#### How to participate

*Written proposal.* Respondents must submit proposals in the format set forth in Annex 1.

#### What will happen after the Call for Ideas?

- I. If the Call for Ideas generates sufficient interest and viable proposals, a matching grant facility with a detailed operating structure would be designed and incorporated in the Georgia MCC compact.
- II. A Request for Proposals will be launched under the Georgia MCC compact.
- III. Proposals will be evaluated by an independent professional panel according to published criteria.
- IV. The highest ranked proposals will be approved and funded subject to funding availability.

## Evaluating the Responses to the Call

Priority will be given to ideas for programs/practices that leverage private sector partnerships and industry engagement.

Priority will be given to ideas for programs/practices that specifically address gender and socially vulnerable imbalances in TVET participation.

We are committed to a speedy, transparent and fair evaluation of ideas. MCA-G will convene a panel of local and international experts. The panel will consider how the proposed programs/practices meet the criteria listed below and how they can contribute to the overall compact objective, taking into account GoG and other donor initiatives in the sector.

Specifically, the evaluation panel will review:

- Partnerships
  - Type of investment proposed (i.e. facility improvement; equipment; teacher professional development; curricula development; twinning with foreign provider; other technical assistance)
  - Potential cohort sizes
  - Length of proposed program/practice and timeframe for delivery
  - Type and level of private sector contribution or industry engagement
  - Academic partnerships and level of partner participation
  - Area of study
  - Sustainability of the program/practice
  - The experience and technical and financial capacity of the proposing entity.
  - The impact the program/practice will have in terms of benefits to women and socially vulnerable groups.
  - The existence of evaluation criteria by which the program/practice's degree of success can be measured
- Amount of funds requested. This should explain in general terms how much will be spent on facilities, equipment, teacher professional development, twinning, and other large areas. Detailed budgets are not required.
- Justification that the funding requested meets the objectives of the Call for Ideas.
- Level/nature of partner participation (financial or non-monetary)
- Academic partnerships and level of partner participation
- The timeframe of proposed program/practice, including start date and length of program/practice
- Projected potential cohort sizes that could benefit from proposed program/practice.
- Technical assistance that is expected to be needed to manage this grant

4.	Which category of funding?	Clearly indicate which of the categories you are applying for. Does your proposed program/practice fit into Component 1 or 2?
5.	Your work in the TVET sector?	Tell us what programs/practices you currently offer, your existing teaching capacity in terms of staff and physical capacity
6.
